PURCHASER AGREES TO THE FOLLOWING CONDITIONS:

This Persian is being purchased as a () PET, () SHOW, () BREEDER.

1. Fur Factor Persians does not guarantee any kitten or cat will win or grand. Most kittens are showable and it is up to the purchaser as to if the kitten shows or doesn't show.
2. IF purchased as a PET, purchaser agrees to neuter or spay this cat before the age of nine (9) months, and agrees and guarantees that this cat will not be used for breeding.
3. Discovery of using a Fur Factor Cat/Kitten in a breeding program that was sold as and for a pet will result in a \$1000.00 fine, Payable on demand to Fur Factor Persians in full.
4. Fur Factor Persians will provide CFA registration paperwork upon proof of alteration by purchaser. Proof of Alteration should be sent to Fur Factor Persians at the address at the top of this page.
5. If purchased as a BREEDER, Fur Factor Persians guarantees breeder to produce live kittens by three (3) years of age, or replace the purchased kitten.
6. Fur Factor Persians guarantees Vaccinations given: RHNOTRACHETIS, CALICIVIRUS, CHLAMYDIA, and PANLUKOPENIA (killed virus). Vaccinations have been given at 7 weeks, and 10 weeks of age.
 - a) Next vaccination due at 13 weeks: (4 way killed or modified live virus recommended), then annual vaccinations.
7. Fur Factor Persians agrees to provide complete history of all vaccinations this cat received along with the following health guarantee:
 - a) Persian is guaranteed healthy when leaving Fur Factor care for up to 48 hours, by taking the kitten buyer agrees kitten appears healthy.
 - b) Buyer agrees to take the kitten to veterinarian of your choice for an exam, within 2-3 days from purchase date or sooner if possible. (All charges incurred from the Vet are the buyer's responsibility.)
 - c) Fur Factor Persians will guarantee the Persian does not have FeLV or FIP at the time of pick up, delivery or shipment.

- d) This Persian has a one-year replacement guarantee against lethal genetic or congenital defects. If this Persian should die or have to be destroyed due to genetic defect before one (1) year old, seller will replace Persian with the next available kitten. This will only be completed upon purchaser providing an autopsy report from a licensed, impartial Veterinary Pathologist stating the cause of death was unquestionable a genetic defect.
8. The buyer understands that during periods of stress; changing homes, changing diet, leaving mom, and littermates, change in living quarters, vaccines, and deworming medications can all trigger negative reactions.
 9. The Buyer agrees to watch the kitten closely for any sign of stress or illness, including lethargy, vomiting, loose stools, listlessness, or anything that seems not normal for a kitten and take the kitten to the vet for treatment.
 10. Under no circumstances will this Cat/Kitten or his/her offspring be sold, leased, or given to any Pet Shop
 11. If for any reason the buyer cannot keep the Cat/Kitten, then the buyer must find an adequate home.
 12. Under no circumstances will this Cat/Kitten be given to an Animal Shelter or Humane Society.
 13. Seller does not recommend de-clawing of Cat/Kitten, but if the buyer wishes to de-claw then it must be done before one (1) year of age, and preferred to be done at the same time of spaying or neutering.
